THE UNITED STATES OF AMERICA,

To all to whom these presents shall come, Greeting:

WHEREAS, an Order of the Secretary of the Interior has been deposited in the General Land Office directing that a fee simple patent issue to the claimant, Martha LeClair Harris, heir of Frederick Harris, an Indian of the Shoshone Reservation, for the northeast quarter of the southwest quarter of Section two in Township one north of Range two east of the Wind River Meridian, Wyoming, containing forty acres:

NOW KNOW YE, That the UNITED STATES OF AMERICA, in consideration of the premises HAS GIVEN AND GRANTED and by these presents DOES GIVE AND GRANT unto the said claimant, the heirs of the said claimant the Land above described; TO HAVE AND TO HOLD the same together with all the rights, privileges, immunities and appurtenances of whatsoever nature thereunto belonging unto the said claimant and to the heirs and assigns of the said claimant forever; and there is reserved from the lands hereby granted a right of way therefor for ditches or canals constructed by the authority of the United States. The land covered by this patent is not liable for any debt contracted prior to this date as provided by Section 5 of the Act of February 8, 1887 (24 Stat., 388, 389) and the amendatory Acts of May 18, 1906 (34 Stat., 182) and June 21, 1906 (34 Stat., 325, 327)

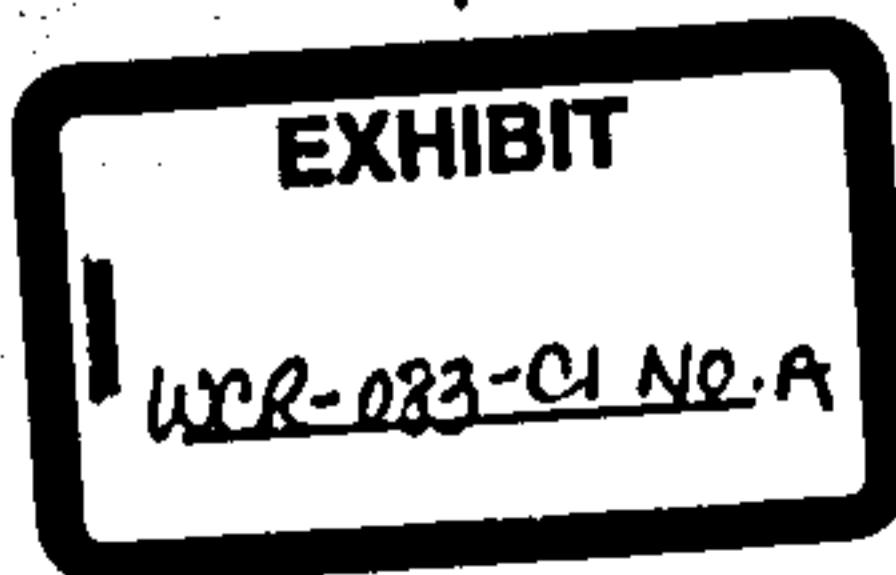

✓ Lot 7, Block 19, of the Town of Riverton, Fremont County, Wyoming also known as 311 East Main Street, Riverton, Wyoming, together with all improvements thereon or appurtenances thereto

AND

✓ The West 47 feet of Lot 2, all of Lot 3, and the East 28 feet of Lot 4, Block 1, McMillan Subdivision, City of Riverton, Fremont County, Wyoming, together with all improvements thereon situate, subject to all easements and restrictions of record

AND

✓ Lot 8, Block 1, Valley Hi Addition to the City of Riverton, Fremont County, Wyoming, together with all and singular the hereditaments and appurtenances thereunto belonging or in any wise appertaining, subject to all covenants, restrictions, reservations, easements, conditions and rights appearing of record and to any state of facts an accurate survey would show.
